- D. DMV shall charge the fees prescribed by law for every set of special license plates issued. Said fees will be charged to the person to whom the special license plates are issued. DMV will collect all fees for each set of original, reissue, or renewal license plates issued with the college or university seal, symbol, emblem, or logotype. DMV shall annually pay the Institution of Higher Learning \$15.00 for each set of license plates issued with the Institution's seal, symbol, emblem or logotype in excess of 1,000 sets pursuant to this Agreement during the term of this Agreement. For the purpose of this Agreement, "annually" shall mean the fiscal year beginning July 1 and ending June 30. If 1,000 sets of the Institution's license plates are not issued then the Institution shall not be entitled to this annual monetary allocation. Any funds so allocated to the Institution of Higher Learning shall be deposited by DMV into the State Treasury and credited to the Institution per Section 46.2-749.
- E. The Institution of Higher Learning shall indemnify and hold harmless DMV and the Commonwealth of Virginia, its employees and representatives from any and all claims, suits and liabilities caused by the Institution of Higher Learning arising in connection with this Agreement. Nothing contained herein shall be deemed an express or implied waiver of the sovereign immunity of the Commonwealth of Virginia or its agencies.
